Fees and Charges

Attention is invited to Administrative Order No. 31 dated October 1, 2012 directing and authorizing all heads of departments, bureaus, commissions, agencies, offices and instrumentalities of the National Government including Government-Owned or Controlled Corporations (GOCCs) to rationalize the rates of their fees and charges, increase their existing rates and impose new fees and charges in pursuant to DBM-DOF-NEDA Joint Circular No. 1-2013 dated 30 January 201.

In connection with the foregoing, the Insurance Commission (IC) shall collect and receive the revised fees and charges effective fifteen (15) days following the completion of publication of this Circular Letter in a newspaper of general circulation in the Philippines.

This Circular supersedes Circular Letter No. 22-2010 dated June 15, 2010 and Insurance Memorandum Circular No. 3-2006 dated June 28, 2006.
